Scrip Program Agreement

Our Lady of Perpetual Help School (referred to herein as “we,” “us” and “our”) sponsors a scrip (gift card) program, which allows you to purchase gift cards. The scrip you purchase through our program generates rebates from the participating retailers. These rebates can be used as a credit to your tuition account, cash, and/or a gift to the school. The parties agree as follows:

1. For administering the scrip program, we will retain .5% of the rebates received from your scrip purchases as an administration fee.

2. We agree to apply the balance of your rebates as designated below (please place a check mark next to the option you select);

\_\_\_\_\_ 50% credited to a specified tuition account; 50% to various school programs (*with this option 50% of your rebate is tax deductible*).

You agree to indemnify us against any loss incurred in connection with there being insufficient funds in your account to cover the checks or ACH transfers you issue to pay for your scrip. We make no representations or warranties of any kind with respect to the scrip. This agreement can be terminated by either of us upon 60 days advance written notice to the other.

Dear Parents

Thank you so much for your patience as we implement the current IRS changes to our Scrip program. This year, we will again have the Scrip, Kroger Card, and Market Day programs. Last year, through your purchases from these programs, you earned close to **\$30,000** in tuition credit.

Orders will still be **due by 12:00 noon on Thursdays**, unless stated otherwise. Afternoon Kindergarten parents should turn their orders in to the office by Wednesday afternoon. Orders are usually sent home the following Wednesday or Thursday.

All families **must** complete the **Scrip Agreement** and an updated **registration form**. Each family should have received a copy of the Scrip Agreement with an address label indicating your name, address and Scrip ID. All forms associated with Scrip can be found at [www.olphsaints.org](http://www.olphsaints.org). Please return your completed agreement and registration form with your first order. You will receive an envelope back with your first order with your family name and scrip ID. **Additionally, there will be a blank space on the label for you to list your child's name, grade & teacher (ie Taylor 6-K) with whom filled orders should be sent home.** *Please do not lose this envelope.* Orders must be sent to the school in this envelope and once filled, your order will be returned in this envelope.

Order dates will be placed on the monthly school calendar. Please pay special attention to those times around Easter Break. **Please use the latest form.** Vendors change denominations periodically, therefore it is important to always use the most current form. These forms will always be available on the school's website at [www.olphsaints.org](http://www.olphsaints.org).

Remember, tuition credit earned on purchases from May 1, 2009 to April 30, 2010, for Scrip, Kroger Cards and Market Day will be applied to your 2010-2011 school tuition. Monies earned may be applied to a Catholic high-schooler's account. Please contact Debbie Ippoliti for more information.
